PROCEDURES & TERMS

- The fees listed on the submission form are applicable notwithstanding an adverse opinion by PSE regarding the condition or identification of any item. Fees will be adjusted as indicated on the front of the Submission Form in the following cases:
 - When a stamp submitted as unused is found to be used.
 - When an item is found to have been misidentified by the submitter, the fee will be adjusted, up or down, based on the value of the item as identified by PSE
 - When an item is determined to be a counterfeit or to have been fraudulently altered with the purpose of changing the apparent Scott Number (e.g., an imperforate stamp with fake perforations to simulate a coil stamp.)
- PSE will endeavor to authenticate and grade stamps within the business day time frame, if any, offered as part of a PSE service. However, PSE will have no liability whatsoever to the customer for incidental or consequential damages due to PSE's failure to process any stamp within any time frame.
- In the event PSE rejects any stamp for grading in accordance with PSE's current grading standards and procedures, the fee paid by the customer for the service cannot be refunded because the determination to reject a stamp required a review by PSE's experts.
- Authentication and grading involves individual judgments that are subjective and require the exercise of professional opinion, which can change from time to time. Therefore, PSE makes no warranty or representation and shall have no liability whatsoever to the customer for the opinion or grade assigned by PSE to any stamp.
- If an applicant seeks an opinion regarding an item which PSE has previously declared to be genuine the applicant must submit, along with the item, the original certificate of authenticity. PSE retains the right to modify or change a previously held opinion and to void or nullify the original certificate. The applicant hereby grants to PSE the right to retain any such prior authentication and agrees to make no claim for the return thereof.
- PSE reserves the right at all times to decline, to expertize or grade any item. Items outside the areas in the List of Services on the Submission Form will be returned at the submitters expense.
- PSE will exercise reasonable care in handling stamps submitted for authentication and grading. However, if PSE determines the Customer's submission was lost or damaged while in PSE's possession, Customer will be compensated based upon the fair market value of the submission as determined by PSE standard procedures which may include filing a claim with our insurance carrier. The insured value stated on the front of this form is for estimating the insurance coverage only, and the fair market value of the stamp may be less than the declared value. In no event shall the total liability exceed the declared value of the stamp.
- Customer agrees to inspect all submitted items immediately upon receipt from PSE and report any damage or discrepancy to PSE within two (2) days of receipt. Customer must also inspect all submissions immediately upon receipt for obvious mechanical errors pertaining to the description of the stamp. Mechanical errors include, but are not limited to such errors as misidentifying a stamps catalog number, color, and/or denomination. Customer agrees to indemnify and hold harmless PSE and its affiliates for all losses and/or claims (including attorney's fees) caused by the circulation or sale of a mis-marked or inappropriate item.
- PSE shall have no liability whatsoever to the customer for any damage to any item, or otherwise, resulting from the alteration, attempted alteration or misuse of a PSE holder.
- PSE shall have no liability whatsoever to the customer for any loss or damage of any submitted item occurring while the item is not in the custody or control of PSE, including during shipment to or from PSE, unless PSE selects the return carrier, whereby PSE is responsible for loss or damage.
- It is absolutely essential that submissions sent to PSE be packaged and shipped strictly in accordance with the requirements of the PSE Shipping Instructions as are in effect. PSE shall have no liability whatsoever for any damage to any submission shipped or delivered to PSE in a manner that does not strictly conform to our written specifications.
- Except as expressly set forth herein, PSE disclaims any and all warranties, express or implied, (including the warranty of merchantability and the warranty of fitness for a particular purpose) regarding our services.
- The courts of Clark County, Nevada shall have exclusive jurisdiction and venue of any controversy or claim arising out of or relating to any submissions to PSE, and THE PARTIES IRREVOCABLY WAIVE THEIR RIGHTS TO A TRIAL BY JURY WITH RESPECT TO ANY SUCH CONTROVERSY OR CLAIM. The court shall award to the prevailing party, in addition to any other relief deemed appropriate, the prevailing party's attorney's fees and costs of litigation, whether or not those are otherwise available to the prevailing party by statute.
- PSE certificates accompanying stamps sent for reconsideration, conversion or encapsulation become the property of Professional Stamp Experts, and will not be returned.
- Customer allows PSE to retain and use images of the stamps submitted for any usage deemed reasonable by PSE Inc. or it's agents for the purposes of advertising, research or any other use including but not limited to usage by third parties for research or publication purposes.
- PSE will not give a grade on any stamp for which that grade would be less than 50 unless specifically requested.

- USE PACKING TAP TO SEAL THE PACKAGE. Be sure to tape all potential openings.
- PSE RECOMMENDS THAT ALL SHIPMENTS CONTAIN SOME FORM OF TRACKING INFORMATION. PSE is NOT responsible for packages lost in the mail.
